
2024 FIRST QUARTER CRIME STATISTICS REPORT

Introduction

- 1. ZIMSTAT publishes statistics on levels and trends of crime in Zimbabwe based on police-recorded crime data, collected on a monthly basis.
- 2. Recorded crime figures exclude crimes that have not been reported to the police
- 3. The information contained here is based on data collected from the Zimbabwe Republic Police (ZRP) Crime Report and Disposal System.
- 4. The crimes are classified according to the United Nations International Classification of Crime for Statistical Purposes (ICCS) adopted in 2016.

National Crime Rate



The police recorded 221,704 offences over the period from January to March 2024. The recorded offences rose by 108 cases from 221,596 offences recorded in the first quarter of 2023.


The national crime rate was 1,460.6 crimes per 100,000 people, a slight uptick from 1,459.9 per 100,000 observed in the fourth quarter of 2023.

There were 87,834 offences committed in the 'Public safety and state security' category, constituting a crime rate of 578.7 per 100,000 population.


Crime Rate by Province – 4th Quarter 2023 & 1st Quarter 2024 per 100,000 Population

There were 266 cases of intentional homicide recorded in the first quarter of 2024, reflecting a rate of 1.8 offences per 100,000 population.

Assaults and threats category was the most frequent 'Act causing harm or intending to cause harm to the person'. The rate for assaults and threats stood at 194.7 per 100,000 population.
